YOU ARE HEREBY NOTIFIED that the School District of Waupaca, Home and Away Ministries, Inc., Agent, has made application to the City Plan Commission requesting a Special Use Permit in accordance with Section 17.230(1)(c)(1) of the Municipal Code, B-1 Neighborhood Business District, Special Uses, to allow for truck garage, repair and service of motor propelled vehicles including the storage and sale of automotive accessories, more fully described as follows, to wit:

Part of 905 10th Street:

A PARCEL OF LAND BEING ALL OF LOT 62 AND PART OF LOT 61, COLUMBIAN SUBDIVISION AND PART OF LOT 5, BLOCK 1, WINSKE'S SUBDIVISION, LOCATED IN THE NORTHEAST ¼ OF THE SOUTHWEST ¼ OF SECTION 29, TOWNSHIP 22 NORTH, RANGE 12 EAST, CITY OF WAUPACA, WAUPACA COUNTY, WISCONSIN, BOUNDED AND DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTH ¼ CORNER OF SECTION 29; THENCE N01°09'08"W, 1644.27 FEET ALONG THE EAST LINE OF THE SOUTHWEST ¼ OF SECTION 29 TO THE EASTERLY EXTENSION OF THE SOUTH RIGHT-OF-WAY LINE OF COLUMBIA STREET; THENCE S89°48'47"W, 167.25 FEET ALONG SAID EXTENSION AND ALONG THE SOUTH RIGHT-OF-WAY LINE OF COLUMBIA STREET TO THE EAST LINE OF LOT 62, COLUMBIAN SUBDIVISION AND THE POINT OF BEGINNING; THENCE S01°52'50"E, 131.50 FEET ALONG SAID EAST LINE TO THE SOUTH LINE OF SAID LOT 62; THENCE S89°30'05"W, 84.50 FEET ALONG SAID SOUTH LINE AND THE SOUTH LINE OF LOT 61, COLUMBIAN SUBDIVISION TO THE EAST LINE OF LOT 5, BLOCK 1, WINSKE'S SUBDIVISION; THENCE S00°51'29"E, 12.64 FEET ALONG SAID EAST LINE; THENCE S88°56'15"W, 34.21 FEET; THENCE N01°04'20"W, 145.08 FEET TO THE SOUTH RIGHT-OF-WAY LINE OF COLUMBIA STREET; THENCE N89°48'47"E, 116.91 FEET ALONG SAID SOUTH RIGHT-OF-WAY LINE TO THE POINT OF BEGINNING.
