Times Square Joint Venture, LLP, owner, has made application for a Zoning Change from “R-1 Single-Family Residential District” to “B-4 Strip Commercial District” for a parcel of land located on West Fulton Street (Part of Parcel No. 34-30-22-7, 800 W Fulton Street) more fully described as follows, to wit:

A part of the Southwest Quarter of the Southwest Quarter, Section 19, Township 22 North, Range 12 East, City of Waupaca, Waupaca County, Wisconsin, described as follows:

Commencing at the Northeast corner of the Northwest Quarter of the Northwest Quarter of Section 30; thence along the West line North 03 degrees 38 minutes 51 seconds West a distance of 25.04 feet along the west line of the City of Waupaca Water Tower (Vol. 730, Page 93); thence South 89 degrees 57 minutes 30 seconds West a distance of 263.21 feet to the point of beginning; thence South 89 degrees 57 minutes 30 seconds West a distance of 1183.11 feet to the easterly right of way line of Western Avenue; thence North 00 degrees 54 minutes 59 seconds West a distance of 540.00 feet to the South western corner of the property of Steve and Carol Klismet (Doc. #838474); thence along the south line of the property of Steve and Carol Klismet North 89 degrees 58 minutes 08 seconds East a distance of 1174.36 feet to the west line of Heartland Custom Homes, Inc (Doc. #662106); thence South 01 degrees 50 minutes 47 seconds East a distance of 539.99 feet to the point of beginning.

Said land contains 636316.4 square feet 14.608 acres.
